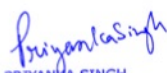

Subject: Valuation of Equity Shares of Kabra Extrusiontechnik Ltd (KEL)

I. Purpose:

We have been engaged by KEL having Registered office at B Wing, Fortune Terraces, 10th Floor, Link Road, Opp City Mall, Andheri (W), Mumbai, Maharashtra, 400053 for the purpose of valuation of equity shares of KEL.

KEL is in the process of evaluating the fair market value of its equity shares proposed to be issued on a preferential basis to persons/entities belonging to the “Promoter & Promoter Group” and “Non-Promoter” categories, in accordance with the applicable provisions of the Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018 (“SEBI ICDR Regulations”).

The “Relevant Date” for the purpose of determination of the Floor Price of the Shares to be issued and allotted as above, is Friday, July 31, 2026, being the day preceding the weekend or the holiday i.e. Monday, August 03, 2026.

The information contained herein and our report is confidential. It is intended only for the sole use for KEL, and only in connection with the purpose mentioned above. It is to be noted that any reproduction, copying or otherwise quoting of this report or any part

II. About the Valuer:

Mrs. Priyanka Singh is an Independent valuer and she is registered with Insolvency and Bankruptcy Board of India ("IBBI") with Registration No.: IBBI/RV/05/2021/14362 for the purpose of carrying out the said valuation of equity shares.

III. Background/Information about KEL

Kabra Extrusiontechnik Ltd was incorporated in 1982. The Registered office of the company is situated at B Wing, Fortune Terraces, 10th Floor, Link Road, Opp City Mall, Andheri (W), Mumbai, Maharashtra, 400053.

The Company is presently listed on BSE Limited (BSE) and National Stock Exchange of India Limited (NSE).

VIII. Approach Considered in our Value Analysis:

General Principle for Valuation

There is no single definition of the term 'Value' that is suitable for all purposes or at all times. The value of a particular asset may vary according to different valuation methodologies that are adopted to ascertain the value for a specific purpose. Valuation of securities is an inexact science. It may sometimes involve a set of judgments and assumptions that may be subject to certain uncertainties.

Broadly there are three approaches of Valuations which are as follows:

- a) "Net Asset Approach"
- b) "Profit Earning Capacity Value" – PECV approach
- c) "Market" Approach
- d) "Comparable Company Method"

IN SUMMARY:

The application of any method of valuation depends on the purpose for which the valuation exercise is performed; relevance of each method under the circumstances of the case and other factors as determined appropriate. The brief methodology in each of the three approaches as mentioned above is as mentioned hereunder:

- **Net Asset Approach:** This method takes into account the value of the assets of the business or the net worth as represented in the financial statements of the Company. For the purposes of arriving at net asset value per share, the net worth so arrived at shall be divided by the number of equity shares issued and paid-up.
- **Profit Earning Capacity Value (PECV) Approach:** This method of valuation presumes the continuity of the business and uses the past earnings to arrive at an estimate of future maintainable profits (FMP). For the purpose of the calculating PECV of shares, commonly accepted approach is to capitalize weighted average of past earnings, at an appropriate rate of capitalization, to arrive at the fair value per share.
- **Market Approach:** The market approach is a method of determining the value of shares based on the quoted price in the respective stock exchange where the shares have been listed.

- **Comparable Company Method:** The Comparable Companies Multiple Method arrives at the value of the company by using multiples derived from valuations of comparable companies, as manifest through stock market valuations of listed companies. This valuation is based on the principle that market valuations, taking place between informed buyers and informed sellers, incorporate all factors relevant to valuation. Relevant multiples need to be chosen carefully and adjusted for differences, such as growth potential, past track record, size, company dynamics, etc.

Selection of Valuation Methodology

The objective of the valuation process is to make a best reasonable judgment of the value of the Equity Shares of the Company. The Company's Equity shares are presently listed on BSE and NSE and are frequently traded at BSE and NSE.

Further, the equity shares of the Company are frequently traded on the nationwide stock exchanges. Accordingly, in terms of the applicable provisions of Regulation 164 of the SEBI (Issue of Capital and Disclosure Requirements) Regulations, 2018, as amended from time to time ("SEBI ICDR Regulations"), KEL requires the valuation of its equity shares for the purpose of determining the issue price of equity shares proposed to be issued on a preferential basis to persons/entities belonging to the "Promoter & Promoter Group" and "Non-Promoter" categories.

Valuation & Conclusion:

In the ultimate analysis, valuation will have to involve the exercise of judicious discretion and judgment taking into account all the relevant factors.

The Fair Market Value per equity share of KEL as per above methodology is INR 374.13/- (Indian Rupees Three hundred seventy four and thirteen paise) Which is the minimum price at which the Equity shares may be issued to the Investors.

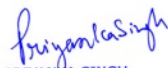
